NO Colorado Proposition 106

On November 8, voters in Colorado face another attempt to devalue God's gift of life. If Prop 106 passes, doctor assisted suicide would be legal in Colorado.

Here are just a few reasons why Prop 106 is dangerous for Colorado:

1 Doctor assisted suicide sends the wrong message

When someone you love says she wants to die, you work to make sure she gets the proper intervention and care. Why would we do any less for Colorado's most vulnerable -- the sick, disabled, disadvantaged and the elderly? Doctor assisted suicide says some lives are simply not worth the effort.

2 Doctors get it wrong

Prop 106 would allow doctors to prescribe assisted suicide for the "terminally ill" -- those with six months or less to live. But how many of us know someone who has long out-lived their prognosis? Doctor assisted suicide would rob patients of extra time -- or even the chance to see a medical miracle.

3 Prop 106 doesn't protect patients or families

Under Prop 106, family members will not be notified if a patient receives a lethal dose of drugs for the purpose of suicide. They have no opportunity to provide care for a loved one who suffers from depression and opts for doctor assisted suicide.

There is nothing to prevent a profit-driven health care system from offering to pay for suicide, but not treatment -- even if the patient wishes to live.
